What triggers a Revenue Commissioners investigation?

In Ireland, you as a taxpayer are responsible for assessing your own tax liability. The Revenue Commissioners is then able to open an investigation to see if you have paid the right amount of tax. This can be done on a selective basis because they think something is wrong. Or it can be random just to check everything is alright. The Revenue Commissioners can consider all aspects of taxation and more recently have also used investigations to ensure that the measures put in place to support the economy through the Covid-19 pandemic have been utilised correctly.

What could an investigation involve?

To start with, the Revenue Commissioners will write to you or visit your business premises. They will potentially want to review all your books and records or will ask for more detailed information about specific transactions on your Tax Return. At the end of the investigation the Revenue Commissioners may look to raise an assessment for additional tax due. As an FPM client, if you are subject to investigation we will respond to the Revenue Commissioners' requests for information and/or attend meetings on your behalf. We will provide our workings with detailed explanations and we can dispute any assessment for additional tax due.

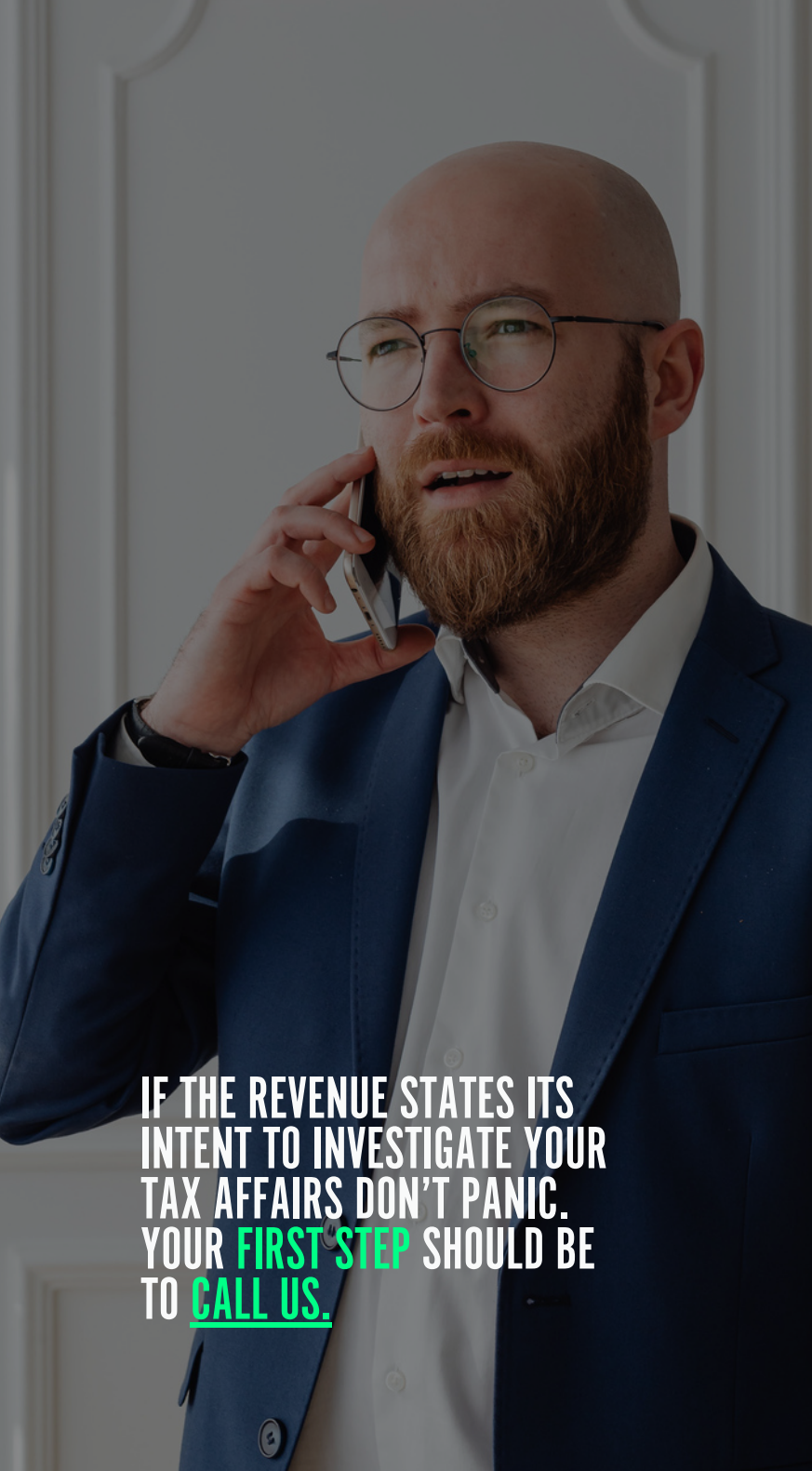
